

10 GOOD REASONS TO OWN AN “ASSAULT RIFLE”

Why would anyone wish to own an [“assault rifle”](#)? And why do so many Marxist Libtard Demoncrops in the USA want them outlawed or banned? The answer(s) to the first question will also provide the answer(s) to the second question... indirectly.

1. First and foremost our Second Amendment to the Constitution makes it crystal clear that, “A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.” Yet nearly every state has now enacted statutes, and the SCOTUS has handed down rulings, which do in fact infringe on this very right. That is reason enough, even if there were no other reasons worth listing.
2. There are tyrannical people that ignorant voters have put into office, at all levels of government, in the USA (and nearly every other country on Earth) and those tyrannical people want to take down our constitutional republic and replace it with a centrally planned communistic form of government which, eventually, will result in a second civil war. Once that happens you will wish you owned a semi-automatic rifle (and probably a handgun) and enough ammunition to defend yourself, your family and your country from said tyrannical rulers and their supporters. See item 1 above.
3. In today’s technological society, owning nothing at all to defend yourself from tyrannical rule and/or mob rule (either one) is the exact opposite of what anyone who wants to remain free should do. The first signs that tyrannical rule is taking over a country is when government wants their citizens unarmed and when government sets up subversive organizations used to trigger riots, destruction and chaos designed to suppress your freedom and rights and increase government control and dictatorship. Owning a simple hunting rifle or a simple revolver, with limited defensive capacity, while they may assist you during a home invasion or robbery will be of little value when large numbers of organized groups or a tyrannically directed military decide to take down the sheep within society and oppressively rule over them.
4. The only way to defend yourself and your country against tyrannical rule is to attempt to match the firepower of your opposition with similar firepower of your own. Tyrannical government with a cooperative and well-armed military will undoubtedly have a huge advantage over a citizen Militia formed to defend the country against them. While the odds of winning a civil war in such circumstances are small, at least with a well-armed and well-regulated Militia said odds are not zero. Forewarned is forearmed. Likewise, it is far better to be forearmed than not well armed at all. Thus one more reason to own an “assault rifle”.
5. Based on the prior reasons, primarily, owning a semi-automatic rifle and/or handgun is a prime objective. By carrying out the process of owning such arms you are also fulfilling the objective of enabling yourself to defend yourself and your family from lawlessness that comes in other forms; such as a home invasion spoken of earlier or when mob rule breaks out and becomes unavoidable to contend with. It is far better to have a reliable semi-automatic weapon on hand in

these conditions than some defensive weapon of less reliable capabilities. It is far better to stack the deck in favor of your own survival when possible.

6. The only way to learn how to defend yourself in extremely deadly situations and conditions is to spend some time planning for them and practicing what do to before such situations arise. By owning at least one semi-auto rifle (and a backup option such as a semi-auto handgun) you will then be able to venture forth and find a safe place to practice using it and also develop the necessary skills needed should a situation arise when you need to defend yourself with it. The first step is to acquire one. But the more important step is to learn how to use one.
7. Given that you agree with the prior logic, the next few reasons should serve to bolster the choice between owning a simple firearm vs. a more sophisticated “assault rifle”. First off a semi-auto rifle will allow faster follow-up shots — semi-autos cycle automatically so you can take accurate follow-ups without manually working a bolt or cylinder.
8. Higher magazine capacity — most semi-auto “assault rifles” accept large capacity detachable magazines, giving more rounds before reloading. And once you expend the rounds in a magazine you can quickly reload with yet another and increase your odds of successfully defending yourself and others when needed.
9. Ergonomics and customization — many semi-auto “assault rifles” offer a wide selection of aftermarket grips, sights, stocks, weight and ability to attach optics, etc. to fit every shooter’s needs and desired application. You can choose from many calibers and find one which fits your arm length, grip and body size for better comfort of operation. You can select a small caliber rifle which produces less recoil or a large caliber for more knock down power. And, once you have equipped it with the sights you favor most, you can use it for hunting, target practice or simple self-defense; even if you never end up needing it to prevent government from ruling over you.
10. Reliability and rapid follow-through — Well-maintained semi-autos are designed for consistent cycling and function. Most of them have been battle tested and will operate reliably in the worst of conditions; even when fouled by dirt, mud and when put under water and then fired. When selecting a firearm for self-defense, take care to select one that should function reliably in all sorts of conditions and situations. While a good bolt action rifle or revolver will also satisfy similar conditions only a semi-auto firearm will do so while meeting the “rapid follow-through” condition at the same time.

When considering all of the above are you able to list even two or three better reasons for NOT owning a firearm in the first place? And, if you aren’t able to do that then what are you waiting for?
