Voter Fraud – 2020 Primary and General Elections – News Reports

Who was recently convicted of voter fraud in Arizona for facilitating ballot stuffing?

An Arizona woman named **Guillermina Fuentes**, 66, was recently convicted for illegally collecting early ballots in the 2020 primary election.^{1 2 3} She pleaded guilty in an agreement with state prosecutors, which saw the more serious forgery and conspiracy charges dismissed.^{1 2 3}

Fuentes, a well-known Democratic operative in the border city of San Luis, was accused of running a sophisticated operation to persuade voters to let her gather and in some cases fill out their ballots.^{1 2 3} However, the prosecutors were apparently unable to prove the most serious charges, dropping three felony counts alleging that Fuentes filled out one voter's ballot and forged signatures on some of the four ballots she illegally returned for people who were not family members.¹

This case has been pointed to by Republicans who have rallied around the possibility of widespread voting fraud in the 2020 election where former President Trump was defeated.¹ However, there's no sign her illegal ballot collection went beyond the small-town politics Fuentes was involved in[, nor is there any reason to believe she was the only such operative. For example...].¹

What other people were connected to the case that allegedly performed ballot harvesting also?

Another woman named **Alma Juarez** was also connected to the case.^{1 2 3} Both Guillermina Fuentes and Alma Juarez were accused of participating in "ballot harvesting".^{1 3} They were seen with several mail-in envelopes outside a cultural center in San Luis on the day of the 2020 primary election.³ Alma Juarez, like Fuentes, also pleaded guilty to one count of ballot abuse.² However, it's important to note that there's no evidence [so far exposed] that their actions were part of a larger "ballot trafficking ring" or that they committed a crime involving the November 2020 general election.²

How many people submitted affidavits supporting President Trump's accusations that voter fraud occurred in Arizona during the 2020 general election?

The Trump campaign released **234 pages of affidavits** which they claimed showed evidence of voter fraud.¹ Ronna McDaniel, chair of the Republican National Committee, and Kayleigh McEnany, the White House press secretary, stated that they had **500 sworn affidavits** alleging **11,000 incidents** of various types of voter fraud.¹ However, an investigation by the [corrupt] Associated Press found that county election officials in Arizona identified "just" **182 cases** of potential voter fraud, and "only" **four** have led to charges so far.^{2 3 4} This is far fewer than the 10,457-vote margin by which Democrat Joe Biden narrowly beat Trump in the state [although some affidavit claims could have resulted in thousands of votes be rejected or switched].²

What are some of the specific "types of voter fraud" alleged by the 11,000 incidents in the 500 sworn affidavits?

Some specific types of voter fraud alleged in the affidavits supporting President Trump's accusations in Arizona during the 2020 general election include: 1^{2}

1. **Democrat counting volunteers wearing Black Lives Matter clothing**: Some affidavits complained about Democrat counting volunteers wearing Black Lives Matter clothing and being "verbally aggressive".¹

- 2. Suspicion over military votes for Biden: One affidavit found it suspicious that about 80 percent of military votes were going to Biden.¹
- 3. **Ballots processed without being checked against the computer**: One Republican poll watcher said some ballots were processed without being checked against the computer and the ballots were "sequential, highly suggestive of fraud".¹
- Allegations of deceased individuals voting: One woman said she checked the online voter registration for her deceased son, who she says was listed as having voted in this election and one four years ago, both after he died.¹

However, it's important to note that many of these allegations were dismissed by judges [supposedly] due to lack of corroborating evidence or credibility of the witnesses [thus covering up any efforts to investigate and get to the bottom of what really happened].²
