As for the knee on the neck BS. What blows me away is the defense had a YEAR to prove it would not kill someone; yet no presentation in court to prove that simple fact. A simple demonstration would have shown the jury exactly how dangerous or not such a method is on a sober human volunteer. However, it also would have shown the jury just how painful and abusive that method of restraint actually is. That part is 100% true. But, to save your client from jail time get on with it.

Greg, you are a wrestling expert. YOU, of all people, could easily demonstrate what Chauvin did using a volunteer about Floyd's size and build (someone like Tim perhaps) and three guys about the size of the cops. Chauvin #1 was 140 lbs and apx 6' (he ain't that big a guy so I hear), the cop #2 holding Floyds handcuffed hands was probably 175 and 5'8". The cop #3 on Floyd's legs was another tall guy; maybe 180 and 6'3". You get someone like Tim and you get some zip-ties. You simulate cuffs behind the back using three or four zip-ties (each wrist and one or two as the chain slack between them). You lay Tim down on a hardwood floor. And you put two guys, one on his legs and one holding his hands and his back down. Then you put your 140 lb 6' guy with one knee on Tim's left shoulder blade and one knee where the neck meets the back muscles and with Tim's face to his right with his left cheek bone on the floor. Then you see how long Tim goes before he screams bloody fucking murder!

Greg, a couple days ago I had my 128lb wife put her knees on me while I tried to hold my hands in the small of my back on our hard wood floor. With her putting maybe 75% of her weight on me (she was afraid to do it exactly like Chauvin did) it really fucking hurt my face, chest and back. I told her to get off after no more than 5 seconds. That was all I needed to know. It did not stop my breathing one bit; just as I suspected. But it hurt like fucking hell. At least in my case.

The thing is Floyd was doped out to high heaven. Fuck, maybe nothing would have "hurt" him. Plus he was a much bigger and stronger a-hole than I ever could be. Didn't he play pro-ball some? Anyway, I do NOT think Chauvin cut off Floyd's air supply, or his blood flow. But, keeping him down that long and waiting for EMTs that long was a fucking bad idea. If they had any mercy at all they should have let up and waited to see what Floyd did after being tortured for 4 or 5 minutes. I think even Floyd was pretty much begging to get in the cop car after 5 minutes. So, they should have given him a chance to co-operate, and if not then 3 strikes and you are fucking out. They gave him plenty of chances before they put him down. But, they should have gave him one last chance, vs. just taunting him the way they did.

They crossed the line, they should all do some time. But, IMHO, they all committed the same basic crime, as a team. And the crime they committed was not 1<sup>st</sup>, 2<sup>nd</sup>, or 3<sup>rd</sup> degree murder. Not by definition. If you read the statutes and examine the testimony and evidence nobody committed murder. Floyd killed himself just as much as the cops did.
